I am sure that the Souvenir being published will capture the essence of the discussions and be liked by its readers.

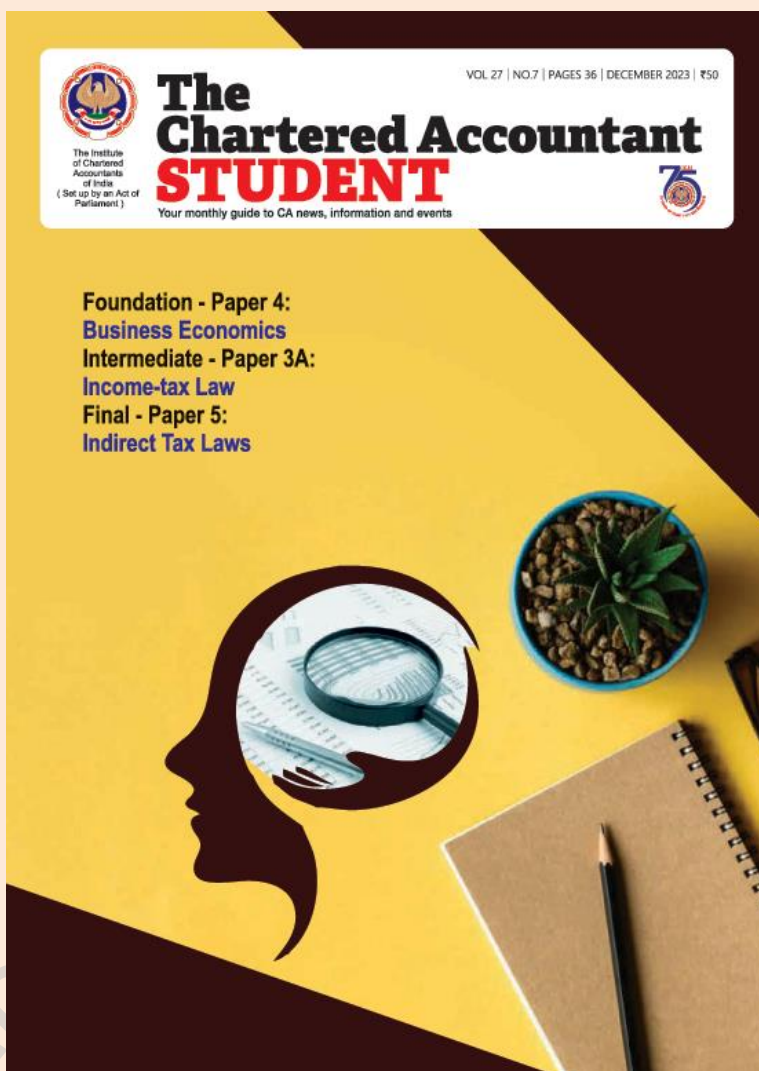
